WHAT DOES FARMINGTON BANK DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and Income
- Account Number, Account Balances and Payment History
- Credit History and Credit Scores

How?

All financial companies need to share customer personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons Farmington Bank chooses to share; and whether you can limit this sharing.

<p>How does Farmington Bank protect my personal information?</p>	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p>
<p>How does Farmington Bank collect my personal information?</p>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> ▪ Open an account, deposit money or pay your bills ▪ Apply for a loan or give us income or investment information ▪ Use your credit or debit card ▪ Use our bill payment services to pay your bills <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
<p>Why can't I limit all sharing?</p>	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> ▪ Sharing for affiliates' everyday business purposes—information about your creditworthiness ▪ Affiliates from using your information to market to you ▪ Sharing for non-affiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>
<p>What happens when I limit sharing for an account I hold jointly with someone else?</p>	<p>Your choices will apply to everyone on your account.</p>

Definitions

<p>Affiliates</p>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies:</p> <ul style="list-style-type: none"> ▪ Our affiliates include companies with a common corporate identity of Farmington Bank's name, such as our Mortgage Servicing Company.
<p>Non-Affiliates</p>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies:</p> <ul style="list-style-type: none"> ▪ Non-Affiliates we share with can include companies that provide services necessary to effect, administer, or enforce a transaction that you request or authorize; Credit bureaus; law enforcement officers, government agencies and courts; and marketing firms.
<p>Joint marketing</p>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you:</p> <ul style="list-style-type: none"> ▪ Our joint marketing partners include credit card companies.
